- AEA Investors (AEA) is a leading global private equity firm that acquired LoneStar in 2010, and through its ownership diversified its end market exposure, entered new geographies and product segments, including the expansion into renewables

Process

- DC Advisory (DC) was engaged by AEA and LoneStar to act as the exclusive financial advisor on the sale of LoneStar

- After a competitive process, LoneStar was acquired by private equity firm, Epiris, in March 2023
- Epiris will support the next stage of the company's growth journey, as it looks to accelerate LoneStar's strategy to support the energy transition and other key growth markets
